AS FAR AS I AM CONCERNED AS FALKLAND ISLANDS GOVERNMENT VETERINARY OFFICER, I WAS MOST PLEASED WITH THE CONDITION OF THE ANIMALS, THEIR QUARTERS AND THE SHIP WHEN IT ARRIVED IN STANLEY. I AM TOLD BY JOSS THAT TWO ANIMALS — THE BILLY GOAT AND THE GALLOWAY BULL — LOST SOME CONDITION DURING THE VOYAGE BUT NEITHER REPEAT NEITHER WAS POOR WHEN THEY REACHED HERE.

SINCE ARRIVAL ALL ANIMALS HAVE BLOOMED AND HAVE TAKEN TO SHORE CONDITIONS EXTREMELY WELL. AS WOULD BE EXPECTED WITH A SUDDEN CHANGE OF DIET TO OUR RICH GRASS, THERE HAVE BEEN ONE OR TWO MINOR DIGESTIVE DISTURBANCES BUT THESE HAVE BEEN FEWER THAN PREDICTED AND ALL WERE VERY TRANSITARY.

ONE CALF HAD A MINOR CASE OF JOINT-ILL WHICH COMPLETELY RESPONDED TO ANTIBIOTIC TREATMENT AND IS NOW QUITE WELL AS ARE ALL THE OTHERS.

I CONSIDER THE FACT THAT THE CALVES WERE BORN AT SEA PER SE TO BE IMMATERIAL AS THE CONDITIONS ON BOARD WERE VERY SATISFACO TORY. INDEED THE CALVES WERE IN BETTER CONDITION THAN THE VAST MAJORITY BORN OUT OF DOORS ON LAND.

I HADEBOTAND THAT THE DAM BLED OF COMBILEATION DECHITING EDOM
