

DEAR SIR,

| WISH TO BRING TO THE ATTENTION OF THE COMMITTEE THE FOLLOWING RROPOSAL WITH THE REQUEST THAT IT BE SUBMITTED TO THE A.G.M. IN FULL FOR CONSIDERATION.

THE PROPOSAL IS THAT WHEN STANLEY GOES ON TO SUMMER TIME, 1.E. ADVANCES CLOCKS ONE HOUR, THE CAMP SHOULD DO THE SAME SO THAT THE WHOLE COLONY WORKS TO THE SAME TIME STANDARD DURING THE APPROPRIATE PERIOD.

As the DISADVANTAGES WE EXPERIENCE THROUGH NOT DOING SO ARE VIRTUALLY THE REVERSE OF THE ADVANTAGES, I WILL MAINLY CONFINE MYSELF TO MENTIONING THE LATTER.

1. WE WOULD ELIMINATE THE DISPARITY BETWEEN CAMP AND STANLEY IN EROADCASTING AND RADIO/TELEPHONE WORKING TIMES THUS REDUCING THE NEED FOR MUCH ADJUSTMENT AT THE TIMES OF ADVANCING AND RETARDING CLOCKS.

2. FOR SOME EAST FALKLAND FARMS, THE AIRCRAFT WOULD BE LESS LIKELY TO ARRIVE DURING THE BREAKFAST HOUR, WHICH I FIND AN IRRITATION.

3. DAYLIGHT IN THE CAMP WOULD BE AN HOUR LONGER IN THE EVENINGS A'D WOULD RESULT IN SAVINGS FOR PEOPLE USING ELECTRIC LIGHT. AND CONSEQUENTLY, SAVINGS TO THE FARMS IN REDUCED GENERATOR RUNNING AND MAINTENANCE WHICH EVEN OUR FAIRLY HIGH CHARGES FOR ELECTRICITY DO NOT PAY FOR.

4. THE LONGER LIGHT EVENINGS WILL BE MUCH MORE USEFUL TO CAMP PEOPLE AND FARMS AND WILL FAR OUTWEIGH ANY DISADVANTAGE WHICH MAY BE EXPERIENCED THROUGH THE LOSS OF DAYLIGHT IN THE MORNINGS WHICH WILL STILL BE QUITE EARLY ENOUGH FOR MOST JOBS SUCH AS EARLY GATHERINGS.

5. THE INCONVENIENCE TO FARMS OF WORKING SHIPS FROM STANLEY WHICH NO LONGER CHANGE TO CAMP TIME WILL ALSO BE REMOVED AND FOR THIS ALONE | WOULD FEEL IT WORTHWHILE.

6. A SMALL POINT BUT IMPORTANT, PARITY WITH STANLEY WILL OCCASIONALLY MEAN THE DIFFERENCE BETWEEN CATCHING OR MISSING A MAIL CLOSURE.

UTIL | HAD GIVEN THE PROPOSAL CAREFUL THOUGHT AND HAD DISCUSSIONS WITH VARIOUS PEOPLE IN STANLEY | WAS OF THE OPINION THAT STANLEY WOULD MAKE THINGS EASIER BY NOT ADVANCING CLOCKS, BUT MAINLY FOR THE REASONS GIVEN IN & ABOVE, STANLEY PEOPLE WOULD BE VERY RELUCTANT TO GIVE UP SUMMER TIME TO SUIT THE CAMP BECAUSE TO DO SO WOULD CAUSE THEM CONSIDERABLE INCONVENIENCE. THE CAMP, { AM CONVINCED, COULD ONLY GAIN BY ADOPTING SUMMER TIME.

IN ASKING THAT THE COMMITTEE MIGHT CONSIDER CIRCULATING THIS LETTER BEFORE THE A.G.M., IN ORDER TO GIVE MEMBERS TIME TO CONSIDER THE IMPLICATIONS OF THE PROPOSAL, I WOULD POINT OUT THAT IT IS NOT SOMETHING ON WHICH WE HAVE TO BE UNANIMOUS ONE WAY OR THE OTHER, AND IF IT IS NOT GENERALLY ACCEPTED, THERE IS NO REASON WHY THOSE FARMS WHO WANT TO, SHOULD NOT ADOPT SUMMER TIME UNILATERALLY. IT COULD WELL BE THAT SOME ALREADY DO, BUT I HAVE NOT HEARD OF ANY. THIS IS NOT A PROPOSED CHANGE MERELY FOR THE SAKE OF CHANGE; THIS ONE OFFERS ADVANTAGES WHICH CAN BE SEEN AND CALCULATED IN ADVANCE.
