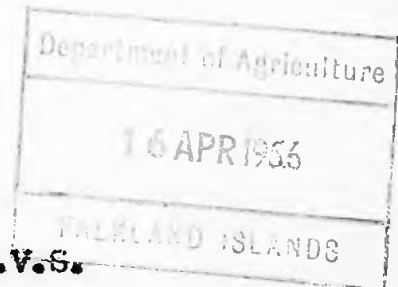

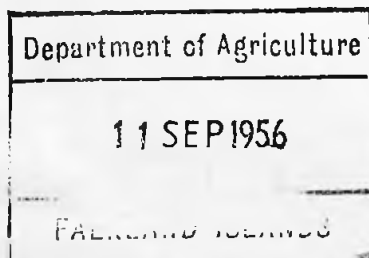

2. Rabies has never been known in these Islands. There are no diseases of dogs except worms and ear canker at times. There is no distemper, in fact the only cases occurred through the importation of a dog from overseas.

3. The dog in question is owned by the Chief Constable, who would bring it home himself, and guarantee that it would not be put ashore at any port of call, nor come into contact with any other animals.

4. I appreciate to the full the necessity for a long period of quarantine from countries where diseases are found, but I do know that the Falkland Islands is free from any contagious and infectious diseases of dogs.
