



The British Antarctic Survey propose to perform the following works between the Public and FIC East jetties:-

1. Widen the seawall by approximately 3' for a distance of 130' eastwards from the Public jetty.

2. Construct a loading platform 40' in length and 24' northwards from the existing seawall. (See drawing for precise locations).

You will see from the attatched letter that the Survey has qualified approval from the F.I.G. The Falkland Islands Company have also written to the Survey to say that they have no objections to the proposal.

We should certainly make provision for the easy renewal of the water main should it become necessary.

The basic method we intend to employ is to drive sheet steel piles into the seabed on the line shown in the drawing, back fill with rock rubble and cap over with reinforced concrete and kurbing. We also propose to install a gate, as shown.

I hope the drawings are self explanatory. If not please contact me for further information.
