

32 DAVIS STREET LOT 4 SECTION 3 – CROWN GRANT 225

This single storey wooden cottage covered in corrugated iron cladding was built by **William MARTIN** circa 1891. Early photographs indicate that there was originally a front porch to the front which has since been removed and the entrance possibly converted to a sash window.


On 19 April 1875 Crown Grant 225 being Lot 4 in Section 3 containing one acre was issued to **William MARTIN** for £12 being bounded on the west by Dean Street and on the north by Davis Street. [CG 225]

On 24 July 1897 **William MARTIN** of Stanley granted to **Thomas MARTIN** of Stanley, "**All** that parcel of Land in the Falkland Islands situate in Stanley being a portion of Special Suburban Allotment No 4 Section 3. Bounded as follows on the North by land in the holding of William Martin 138 links On the South by Crown Land 138 Links, on the East by land in the holding of Otto K Fugellie 185 links, On the West by Crown Land 185 Links. The whole containing ¼ of an Acre more or less" for five shillings. [BUG-REG-5; 224] - rear half of 30 and 32 Davis Street



On 7 May 1891 **William MARTIN** of Stanley granted to **Thomas MARTIN** of Stanley, "**All** that parcel of Land in the Falkland Islands situate in Stanley being a portion of Special Suburban Allotment No 4 Section 3 bounded as follows. On the North by Crown Land 138 links. On the South by land in the holding of Thomas Martin 138 links. On the East by land in the holding of Robert Allen 188 links. On the West by Crown Lands 185 links with all houses erected thereon. The whole containing ¼ of an acre more or less" for £350. [BUG-REG-5; 336] - front half of 30 and 32 Davis Street

On 22 January 1920 **The Heirs of Thomas MARTIN deceased** of Stanley granted to **Vere Falkland SUMMERS** of Stanley, "**All** that parcel of land situated in Stanley being a portion of special suburban allotment No 4 Section 3. Bounded as follows on the north by Crown Land 69 links. On the South by Crown Land 69 links on the East by land in the holding of Robert Allan 370 links on the West by land in the holding of the said heirs of the Estate of Thomas Martin deceased 370 links with all buildings erected thereon, the whole containing one quarter of an acre more or less" for £60. [BUG-REG-8; 311] - 32 Davis Street



On 30 June 1926 **Vere Falkland SUMMERS** of Stanley granted to **Thomas GOODWIN** of Port Stephens, "**All** that parcel of land situate in Stanley being a portion of special suburban allotment No 4 Section 3. Bounded as follows on the North by Crown Land 69 links, on the

South by land in the holding of the said Vere Falkland Summers 69 links, on the east by land in the holding of Robert Allan 265 links on the west by land in the holding of Joseph Lee 265 links together with all buildings erected thereon" for £525. [BUG-REG-9; 319] - front of 32 Davis Street

Thomas, a shepherd at Fox Bay, died 15 May 1939 in KEMH, Stanley. Thomas left all of his estate equally to his daughter Harriet and his granddaughters Bessie and Linda Kivell. [BUG-REG-11; 33]
