


### 34 DAVIS STREET LOT 4 SECTION 3 – CROWN GRANT 225

On 19 April 1875 Crown Grant 225 being Lot 4 in Section 3 containing one acre was issued to **William MARTIN** for £12. The plot was bounded on the west by Dean Street and on the north by Davis Street. [CG 225]

On 7 April 1896 **William MARTIN**, shoemaker of Stanley, and **Isabella MARTIN**, his wife, granted to William's son-in-law, **Otto Konrad FUGELLIE**, master mariner of Stanley, "*All that parcel of land in the Falkland Islands situate in the town of Stanley and bounded as follows. On the East by land in the occupation of Jose Fiall Farias one ¼ acre. On the West by land in the occupation of the said William Martin one 1 ¼ acre on the North and South by land of the Crown. This is the second quarter acre alienated from allotment No 4 Sect 3 Special Suburban*" for one shilling. [BUG-REG-5; 153] - 34 Davis Street



On 4 July 1899 **Otto K FUGELLIE**, through his attorney Andrew E BAILLON, granted to **Robert J ALLAN**, master mariner of Stanley, "*All that parcel of Land in the Falkland Islands situate in the Town of Stanley and bounded as follows:- on the East by land in the occupation of José Fiall Farias one ¼ acre - On the West by land in the occupation of William Martin one ½ acre. On the North and South by lands of the Crown. This is the quarter acre alienated from Allotment No 4 Sec 3 Special Suburban*" for £29. [BUG-REG-5; 287] - 34 Davis Street

On 17 September 1924 **Robert John ALLAN** granted to **Charles Goss ALLAN** "*All that parcel of land in the Falkland Islands situate in the Town of Stanley and bounded as follows:- On the East by land in the occupation of John Skilling one ¼ acre. On the West by land in the occupation of Vere Falkland Summers one ¼ acre. On the North and South by lands of the Crown. This is the quarter acre alienated from allotment No 4 Sec 3 Special Suburban*" for £80. [BUG-REG-9; 213] - 34 Davis Street

On 5 August 1941 **Charles Goss ALLAN** of Stanley granted to **William Dickson MORRISON** of Darwin, "ALL that parcel of Land in the Falkland Islands situate in the town of Stanley and bounded as follows:- on the East by Land in the occupation of John Skilling one ¼ acre, On the West by land in the occupation of J Goodwin one ¼ acre, On the North and South by lands of the Crown. This is the quarter acre alienated from allotment No4 Sec 3, special suburban" for £118. [BUG-REG-11; 254] - 34 Davis Street
