3 PHILOMEL STREET - GLOBE STORE LOT 89; CROWN GRANTS 8, 306, 314 & 326

The substantial stone building which used to stand on the corner of Philomel Street and John Street appears to have started life as two semi-detached stone cottages, both of which appear to have been built by Andres Pitaluga, the first sometime between January 1858 and 1870, and the second at some point between November 1862 and 1870. Charles Williams then extended and combine the buildings into one attractive stone building sometime after his purchase in 1879 and by the 1890s.

On 5 August 1844 Crown Grant 8 was issued to **John SCULLEY** for £50 being Lot 89 in Section O containing half an acre with a front to John Street and rear to Fitzroy Road. [CG 8]






- 1. Stone cottage (semi-detached with 2.) 89e

On 29 May 1876 Edward Thomas SMITH administering **Estate late Laurence ENNIS**, blacksmith of Stanley, granted to **Charles WILLIAMS**, tailor and publican of Stanley, a portion of Town Lot 89 containing 20 perches more or less and bounded "on the North by John Street 33 feet, on the East by two other portions of the same allotment 165 feet, on the South by the Fitzroy Road 33 feet, and on the west by the remaining part of the said allotment in the holding of Francis Parry 165 feet, together with all erections thereon" for £50. [BUG-REG-3; 54] - 89g and ½ 89b

On 24 June 1876 Edward Thomas SMITH administering **Estate late Laurence ENNIS**, blacksmith of Stanley, granted to **James HOCKING**, gaoler of Stanley, a portion of Town Lot 89 containing 24 poles more or less and bounded "on the North by a part of the same allotment 66 feet on the East by Philomel Street 99 feet, on the South by the Fitzroy road 66 feet, and on the west by another portion 99 feet, together with the Dwelling houses erected thereon, and all other erections thereon" for £290. On 5 July 1879 **Alexander PITALUGA** of Rincon Grande, granted to **Charles WILLIAMS**, tailor of Stanley, the north east corner of Town Lot 89 containing 16 perches more or less and bounded "on the North by John Street one hundred links, on the East by Philomel Street one hundred links on the South by a portion of allotment eighty nine one hundred links, and on the West by another portion of the same allotment one hundred links, together with the messuage and buildings thereon" for £140. [BUG-REG-3; 127] - 89e

Francis PARRY, age 75, died in Stanley 21 April 1885. In his will dated 13 April 1885 Francis left his house and land in Stanley to his second wife Marcella during her lifetime and on her death to be sold and the proceeds equally divided between his godson, George Isaac Turner of Stanley and the remainder how his wife should direct in her will. [BUG/REG/3; 261]

The J R Kelly stranded off East Tussock Island in May 1899 and the wreck was bought by **Charles WILLIAMS**. The two semi-circular steps up to the west end porch of the stone building on John Street were mill stones salvaged from the wreck


Marcella PARRY, age 65 and British, died in Stanley 23 July 1902. In her will dated 28 June 1898 Marcella left all her property to Miss Florence Blake residing in Bridge, Petherton, Somerset, England.

On 22 May 1903 George Turner, executor estate **Francis Henry PARRY**, granted to **George Isaac TURNER** for £275 "**All** that parcel of land in the Falkland Islands situate in the Town of Stanley being part of Town Lot No 89 bounded on the North by John Street 33 ft on the South by H Mannan 33 ft on the east by C Williams 99 ft on the west by Lot 88, 99 ft. Also Town Lot No 88e bounded on the North by John Street containing 20 perches. Also the parcel of land situated in the Town of Stanley containing 4 200/625 perches bounded on the north by lands of Marcella Parry 50 links on the East by lands of Henry Mannan 54 links on the south by Fitzroy Road 50 links on the West by lands of William Stephen Elmer 54 links" for £275. [BUG/REG/6; 27] - Crown Grant 8, 14 & 313 - 89h

Charles WILLIAMS, age 66, died 10 February 1907 in Patagonia. The majority of his estate passed to his eldest surviving son, **Louis WILLIAMS**.

On 4 September 1909 **George Isaac TURNER** granted to **Estate late Charles WILLIAMS** "All that parcel of land in the town of Stanley being part of Town Lot No 89, bounded on the north by John Street 33ft, on the south by H Mannan 33ft, on the East by C Williams 99ft, on the west by lot 88, 99ft, also Town lot No 88c, bounded on the north by John Street containing 20 perches, also the parcel of land situate in Stanley containing 4 200/625 perches bounded on the north by lands of Marcella Parry 50 links, on the east by lands of H Mannan 54 links on the south by Fitzroy Road 50 links, on the west by lands of William Elmer 54 links" for £275. Louis WILLIAMS, age 44, died 20 November 1913 from an accidental gunshot. He left no issue and control of his estate passed to his wife, **Ada Marjorie WILLIAMS**.

In 1948 Ada WILLIAMS and her sister, Grace BOSSINGHAM, returned to England.

Ada died in 1950 and, under the terms of her will, **Ernesto ROWE** inherited half of the Estate Louis Williams with the other half to become his on the deaths of her remaining siblings.

Ernesto ROWE, age 79 and a general merchant, died 22 December 1975 in Stanley. The Globe Store continued trading after his death and burnt down 15 June 1982 after being set on fire by Argentines after their surrender.

The Penguin News of 23 August 1982, pg 9, reported 'At least one building has been demolished altogether. Most people lament the fact that this was necessary for it was the ancient Globe Store which came under the blade of the bulldozer. But the walls that remained following the fire sparked off by Argentine prisoners were unstable, and a threat to safety.'
