I have the honour to transmit to you a copy of correspondence with the Admiralty with regard to a claim for £71:2:8 in respect of certain hospital equipment and furniture supplied in connection with the preparations for the reception and treatment of the wounded landed in the Falkland Islands after the naval action of the 8th December, 1914.

3. I understand that Mr Allardyce, who authorised the arrangement referred to by the Admiralty, is of opinion that the Colony will gladly pay the sum claimed; and I request that the Legislative Council may now be invited to consider the question of voting the amount required. On learning from you that the Council have agreed to the vote I will instruct the Crown Agents for the Colonies to make the necessary payment.
