That, to my mind, is the "Official" war memorial.

WAR MEMORIAL.

Government has under consideration the form which a memorial to those who fell in the 1939 - 45 War should take. The Public Relations Committee was recently informed that, as at present advised, it was proposed to add all such names to the plinth of the Cross of Sacrifice at the Cemetery, where the names of those who fell in the 1914 - 18 War are already inscribed.

It is also suggested that the vicinity of the Falkland Islands Battle Memorial should be laid out as a Garden of Remembrance, in particular association with the Royal Navy, whose intimate connexion with the Colony is a matter of pride.

The views and suggestions of the public will be very welcome in developing plans for the realization of these schemes.

There is in the Falkland Islands a need of a home for Chronic cases and I think it reasonable to suggest that the proposed Memorial might include a home for these unfortunate individuals.?

1. Provided space permits on the pedestal of the cross then I suggest the names be inscribed thereon as on those for 1914-18. The Government mason should be able to do this, although he may take longer than a monumental mason would.

2. I say in para. 1. of space permits. as I am not at all sure what names are to be included. Any of the following groups might feel entitled to be included.

- (a) Men & women born in the F. Is. or dependents who lost their lives as the result of enemy action anywhere in the world, <sup>or died O.A.S.</sup> & whether members of the F.I.D.F. or not, & whether resident in the Colony at the outbreak of war or not.
- (b) Men or women who left the Colony to serve in H.M. Forces & subsequently were killed or died O.A.S.
- (c) Officers & ratings from H.M. Ships Exeter, Ajax & Achilles who died from wounds in the Colony after the Keeweenaw Action.
- (d) Any man from the Merchant Navy who died in the Colony.
- (e) Men of the Defence Force who died while on the active list.
- (f) Any civil defence personnel who died while so enrolled.
