2. You reported in your letter No. 75 of the 31st December, 1913, that a sum of £300 has been received by you from Messrs Chr. Neilsen & Company in respect of the Norge Whaling Company's licences for the 1919-1920 season; and by your letter No. 64 of the 30th September, 1913, that you were retaining on account of future licences the sum of £800 received by you from Mr N. Bugge in respect of the 1918-19 whaling licences for the Hektor and Hvalen Companies. The whaling licences for these Companies may therefore be issued on receipt by you, and the fees from the Hektor and Hvalen Companies (£800) paid in to credit of this Government.

3. With regard to the other licences they should be issued on payment of the necessary fees. I am notifying the various Companies of the despatch of the licences to you, and requesting them to apply to you for their delivery transmitting the necessary fees for the same.

4. All licences are issued subject to the condition that all whale oil shall be exported to, and for delivery and sale in, the United Kingdom, unless authorized by special licence from the Secretary of State for the Colonies.

Licences Nos. 78,79,80,82 and 83, for third whale catchers, are granted subject to disallowance by the Secretary of State for the Colonies.


