(1) An Ordinance to prohibit former enemy aliens landing in the Colony without a permit.

His Excellency explained that the principle of this measure originated from the Imperial Government and that he thought similar legislation was being enacted throughout the British Empire at the same time. The Ordinance would provide for a careful scrutiny of any former enemy alien brought into the waters of the Colony on board any vessel, and no such person would be permitted to land in the Colony unless provided with a permit issued by the Colonial Secretary with the approval of the Governor.

(2) An Ordinance to prohibit the landing in South Georgia and to deport therefrom any alien considered dangerous to the peace and good order of the Dependency.

The Governor explained that the passing of this Ordinance was rendered desirable by the repeated indications during the past year of so that there was considerable unrest among the foreign labour employed in South Georgia, over the matter of wages paid by the whaling companies. The object of the Ordinance was to strengthen the hand of the Magistrate resident in the isolated Dependency in maintaining good order. The Ordinance was not to be used by the Magistrate merely to stop strikes or settle labour questions, but only for the preservation of good order.

- 2. The Governor extended a welcome to the Colony to Lieutenant-Colonel T. R. St. Johnston, Colonial Secretary, who was present and took the required oath and his seat as a Member of the Council.
- 3. Despatches received on the 15th September were laid before the Council and read.
- 4. M.P. 652/19. The Governor laid before the Council a Circular despatch dated the 5th June, 1919, received from the Secretary of State, forwarding aopies of Imperial legislation on the subject of Air Navigation, and requesting that such legislation as might be considered necessary locally be submitted to him in draft before enactment. The Council advised that they saw no necessity for any legislation locally on the subject at the present date. The Governor concurred and said he would so report to the Secretary of State.
- 5. M.P. 635/19. A Circular despatch from the Secretary of State, dated the 2nd May, 1919, was laid before the Council

and read. The despatch related to the greatly increased cost of living in the United Kingdom, and its effect on the holders of pensions from Colonial funds residing there. The Secretary of State considered that the circumstances consistuted a hardship on Colonial pensioned Officers and invited the assistance of the Colonial Government in making some financial arrangement which should relieve them. The Governor informed the Council that after consideration of the matter, he proposed, subject to any suggestions or amendments which the Council might desire to put before him, to submit to the Secretary of State a draft Ordinance providing for an increase in the rate of pensions granted to public Officers as follows :- The pay ane emoluments on which public officers have been pensioned or granted retiring gratuities or on which they would normally be pensioned or granted retiring gratuities, to be increased by 25 per cent. if such pay and emoluments do not exceed £300 per annum, and by 20 per cent if such pay and emoluments exceed £300 per annum, subject to the following provisions, (a) that the minimum additional grant amount on which the supplementary additional xanount xanxwhich pension or gratuity is calculated shall be £26 per annum, and (b) that no officer with salary and emoluments exceeding £300 per annum shall receive a smaller supplementary pension or gratuity than he would have received if his salary and emoluments had been exactly £300 per annum. 2. M.P. 915/19. Correspondence was read to the Council relating to the termination on the 31st December, 1919, of the Interinsular Steamer Communication Agreement, 1916. Under the terms of the present Agreement the Falkland Islands Transport Company Limited received a monthly subsidy from the Colonial Government amounting to £80. In view of the increased cost of running the s.s. "Falkland" the Agent of the Company stated that the Company would not be able to renew the Agreement unless a greatly increased subsidy were paid in future, and suggested £160 a month as the subsidy desired. The Administrator was of the opinion that in the eventof the Government refusing to consider the proposed increase of 100% it was not improbable that a service, possibly irregular but sufficient for the needs of the Colony, could be obtained, as for the purposes of their trading the Falkland Islands Company would find it necessary to run the s.s. "Falkland" or another vessel in order to carry produce to Stanley for shipment, and that this being so it seemed probable that the Transport Company would eventually be glad to receive the subsidy at the past rate of £80 a month, or perhaps a little more, rather than continue to run without a ten Government subsidy at all. attention to seation 5 of the Land

In this connection His Excellency laid before the Council a Confidential despatch from the Secretary of State demed enclosing correspondence between the Colonial Office, the Admiralty and the Foreign Office relative to the load off a patrol gunboat or coastal motor boat to the Colonial Government for the protection of the Fur Seal rookeries.

Negotiations were at present proceeding with regard to this proposed loan and on the receipt of further reports as to the exact requirements of the rookeries a decision would be come to in the matter.

Taking this into consideration together with the renewal of the Interinsular Steamer Communication Agreement the Council were of the opinion that it was not necessary to entertain the Agent's proposal of an increase of 100% in the subsidy paid by the Colonial Government, and advised that copies of the correspondence should be forwarded to the Secretary of State.

The Administrator concurred and said he would forward copies accordingly together with the Council's recommendation that the proposed subsidy should not be considered.

the Manager of the Falkland Islands Company Limited had again raised the question of the acreage of Lafonia and adjacent islands, which had been declared by the Governor in Council on the 5th December, 1918, to be 700,000 acres.

A letter from Sir Alexander Stenning and Partners was now submitted from which it appeared that from a measurement of the Admiralty Chart Lafonia and adjacent islands should be considered to be 455,000 acres. The Manager asked that the declared acreage should be amended accordingly.

His Excellency said hat he had caused a letter to be written to the Company drawing attention to section 5 of the Lander

Tax ordinance, 1918, in which it was provided that the acreage declared by the Governor in Council should be deemed to be the acreage of the land u til such time as the correct acreage should be ascertained by survey made, and adding the that it did not appear that Sir Alexander Stemming and adding the Partners' letter could be regarded in any way as a survey. His Excellency said that at present he had no intention of altering the acreage declared by the Governor in Council in December last, but that he proposed to forward copies of the correspondence for the consideration of the Secretary of State with whom no doubt the Head Office of the Falkland Islands Company Limited were now taking up the matter.

4. M.P. 874/19. The Administrator asked the Council's opinion as to the disposal of the Peninsula Farm, lately tenanted by Mr James Smith and now vacant owing to the death of Mr Smith and also of his widow. His Excellency read to the Council a minute of Governor Young's dated the 14th September, 1918, (M.P. 714/18) expressing the opinion that the farm should be allowed to lie fallow for a few months after which it might be advisable to consider leasing it to some suitable person who would be willing to conduct a dairy farm to supply Stanley with milk, eggs, meat, &c., at fixed prices, or to add it to Stankey Common as a special feeding ground for stock when the rest of the Common was unable to supply sufficient feed.

His Excellency pointed out that 14 months had now elapsed and a suitable lessee in the person of Mr J. McGill had now presented himself. Mr McGill was the only competitor in the butchery business of the Falkland Islands Company.

Mr McGill had laboured under difficulties in the past in the supply of meat and it was in the interests of the community of Stanley to afford him such assistance wax as was possible.

The Administrator said he had already given Mr McGill the use

of the Peninsual Farm on a konthly tenancy.

The Council advised that Mr McGill should be offered the lease of the Farm for one year, on the understanding that at the end of that time negotiations should be entered into with a view to running a dairy farm on definite lines with fixed on prices for produce.

The Administrator concurred and ordered accordingly. ever-

- 5. M.P. 834/19. Telegrams from the Secretary of State respecting the denaturalisation and deportation of former enemy aliens were read to the Council. The Council advised that as the number of persons to whom the telegrams were applicable was very small, and that of those persons there were none who could be regarded as particularly undesirable members of the Community, no action seemed to be called for in this Colony.

 The Administrator concurred.
- 6.M.P. 666/19. The Administrator informed the Council that a Medical Board had been appointed to consider the health of Mr G. T. King, Foreman Carpenter, and had reported that owing to his age and the condition of his health it was unlikely that he would again be able to return to work. The Council recommended that Mr King should be granted leave of absence on full pay until the 31st December, 1919, and then retired on pension in accordance with the provisions of the Pensions Ordinance, 1906.

The Administrator concurred and ordered accordingly.

7. M.P. 842/19. The Administrator informed the Council that in view of the increased wages now paid to members of ships' crews &c. representations had been made to him that it was desirable that the rates of overtime paid to Customs Officers should also be advanced. The Council advised that an increase of approximately 50% should be allowed. The Administrator

concurred and the attached amending Rules were made accordingly.

8. The Administrator informed the Council that complaints had been made to him with regard to the management of the Government Officers' Canteen, and though he hoped that on investigation the complaints would be found to be less serious than at first sight they appeared to be, nevertheless he considered it right that some enquiry should be made. The Colonial Secretary was ex officio Chairman of the Directors of the Canteen, but as he was holding the office of Administrator His Excedlency preferred to nominate a deputy to preside in his place, and had named Mr T. N. Goddard inxhixxplacex for this purpose. A Meeting would be held shortly and the Administrator hoped that he would be able to report satisfactorily to

the Council when next it met as to the present condition of the Canteen.

The Administrator thanked the Members for their attendance and adjourned the Council sine die.
