Dear Sirs,

We have to thank you for your letters (2) of the 21st May.

SHIPMENTS. The number of bales, etc. will be telegraphed to you in future; this is referred to later under the heading of "Code Supplement".

MANIFEST. One spare copy of the Manifest will be sent you in the case of all future produce shipments.

"FALKLAND" SUPPLIES. In the circumstances you need not approach lessrs Castel with regard to granting a 5% cash discount.

WH/LERS. We thank you for your trouble in furnishing us with this information.

PARANA PINE. Please send us quotations, F.O.B. Montevideo for the standard cut sizes.

STORES - FRUIT. The fruit by last voyage of the "Falkland" arrived in better condition than for some time past - no doubt due to the careful selection made by you.

"BELLORADO". We confirm telegrams sent regarding this vessel, and will advise you later both by telegram and in writing the quantity of bales being shipped about the 2nd June to catch her.

CODE SUPPLEMENT. Please make the following change under Indicator Z O, Sub-Indicator Y F:- U J, for "bunches of bananas" read "crates of bananas".

With reference to your request to Mr Creamer to allot a few extra texts giving the number of bales etc. shipped each time by the "Falkland", we attach a list which we think should meet with all requirements; please advise us if you think of any further important phrases which might be added.

Code Supplement (cont'd). Our new steamer is to be called s.s. "LAFONIA". Under Indicators M A (page 57) and P Y (page 77) please allot the cypher L U to read"s.s. "Lafonia" in each case, for our private use.

Will you kindly confirm having made the above additions and alterations?

CARGO FOR "FALKLAND" - JUNE VOYAGE. A Mr Leslie Hardy is expecting some cargo (probably some 40 cases of provisions, wearing apparel, fancy goods etc.) to be landed at yours ex "Desna" in transit for Stanley. This may be shipped per "Falkland", always providing there is room for it without shutting out any of our own or Government's cargo. You may pay any transhipping charges on this cargo, showing such debit in your account clearly as "a/c L.Hardy".

CARGO FOR "FALKLAND". With regard to shipment of cargo generally, you may take it as a standing instruction to ship anything that may be affering for cutside consignees (such as L. Williams Estate, Hutchinson, Summers, etc, etc,) provided that all own space is adequately assured first. You, of course, are allowed a free hand in arranging with shippers such things as the amount of notice you require before accepting their shipments.

To conform with custom, would you please see that Bills of Lading for cargo from yours to Stanley are claused "Freight payable at Destination"?

MR G.R.L.BROWN, the new Governor's Private Secretary, may wish to draw some money while in Montevideo. Would you kindly advance him up to the value of £ 20 (Twenty pounds), debiting us in account.

PASSENGER LISTS FOR "FALKLAND". ould you be good enough to send us a further supply of the Passenger Lists we are using for the "Falkland's" voyages to your port.

FALKLAND ISLANDS GAZETTES. We are sending by Captain Evans this time the F.I.Gazettes (with Indexes) for 1928/1930, and we shall be obliged if you can have these bound for us in one volume. We also send an old volume to give you an idea of the type of binding, etc, required - please return this with the new volume.

MR L.A.MICHIE, a Government Schoolmaster, travels to yours per "Falkland" this time, carrying Passage Order A 209 on the Purser of s.s. "Desna". Will you please arrange for him to stay at an hotel during the few days he will be at Montevideo, charging the amount of his bill there to us. We think the Hotel "Globo" would be quite suitable.

MAILS EX BUENOS AIRES. As it appears that the Argentine Government do not forward mails via Montevideo unless specially asked to do so, we shall be obliged if you can make arrangements for Argentins mails for this Colony to be at Montevideo to catch the "Falkland" whenever she is due at yours.

MANIFESTS. Further to the matter of Manifests for "Falkland" to yours, could you obtain for us, from the Uruguayan Ministry of Foreign Affairs, a supply of printed Manifest Forms such as are used for these shipments. We shall probably get them quicker this way than by applying officially for them from here.

PASSENGERS. Passengers to yours by this opportunity are Mr G.R.I.Brown, about whom we have already written you; Mr L.A. Michie, holding Passage Order on Purser of "Desna"; Mr D.Lehen, holding Passage Order (3rd Class) on Purser of "Asturias", and Mr E.Tombs and Mr V.Summers, both of whom intend to make their own arrangements to travel home to England by the cheapest route possible.

SWUD LINK CABLE. We have this matter in hand but cannot give any particulars yet, although we do not expect to obtain cable here. Lloyds Surveyor informs us he can procure this cable, second hand, from England at a moderate price, he has telegraphed and expects a reply by air-mail. We will keep you advised of further developments.

Parana Pine is what is called here "Brazilian Pine" and is imported from Brazil over the frontier by Railway in bulk, being prepared and sawed here in the Mills. It is also used in the Argentine but sometimes described as Parana Pine.

SAILINGS L & H AND MC IVER. The Lamport and Holt sailings are: - "BIELA" for Liverpool on the 7th June and afterwards two or three sailings per month. fares \$ 173. u.g. Mc Iver Line can give no information until next month.

WOCL AND SHEEPSKINS. Part of this cargo was transhipped to s.s. GCGOVALE" direct, but we regret steamer could only take 260 bales wool and 27 bales sheepskins, owing to lack of space. 
