We beg to acknowledge receipt of your letters of the 1st, 14th, 26th 29th, 30th April and confirm our letter of the 29th March as per attached press copy and also wirelesses exchanged as per list which we hope you will find in order.

MINISTERIO DE RELACIONES EXTERIORES. We have paid to this office the sum of \$ 56.10 equivalent of £ 7.4.11 as requested and are debiting you in

current account.

MRS W LUXTON. We note that this lady is arriving per "HICHLAND PRINCESS" and we will very pleased to look after her transhipment to "LAFONIA". FORDSON TRACTOR". This has been purchased and is being forwarded per "LAFONIA". Under separate cover we are sending several catalogues and leaflets regarding same. You will observe that total cost of Tractor is under our quotation, this is due to the fact that we have obtained a reduction in the price of 5%.

SECOND HAND SACKS. We enclose quotation received from Mr O.Bianchetti for the supply of new and used secks. As we could not inform him of the quality of sacks required, he has quoted for several qualities. PASSENGERS ARRIVED PER "LAFONIA". All passengers errived safely and procedeed to England per "HIGHLAND MONARCH" and "ARLANZA". PITMANS INSTRUCTOR. This has been bought and sent forward per "LAFONTA".

GRANJA ADELIA CHEESE. We have now received the 12 forms of this item and have sent them per "LAFONIA". Captain Roberts has also obtained 6 forms for the ship.

PETTER OIL ENGINE. Messrs Coates have written to the Factory by airmail with regard to the supply of Ebonite brush carrier but no reply has yet been received.

TIMBER. We have gone carefully into this matter with Mr Bonsignore but regret to inform you that prices quoted in your letter of 11.2.32. ere very much higher than those quoted here for Brazilian pine for instance:-

CARGO IN TRANSIT. We beg to advise having transferred to "LAFONIA" today the following cargo: - One case Records ex "AMERICAN LEGION" shippers: - R.C.A. Victor Co Inc. 20 cases Me4neralwater ex "CAMPANA" shippers: - Cia de la Source Perrier. 3 cases Glassware ex "DESEADO" shippers: - Lowden Connell & Co Ltd.

A LE VAVASSEUR. We have advice that 23 cases of wines and liquers are being sent to you in transit but regret the steamer carrying goods

has not yet arrived.

"DESEADO" CARGO. We have received three cases containing rubber boots and oil skins marked L.H. which cases cannot be transferred

to "LAFONIA" owing to goods being consigned to Order and B/L not having yet arrived. We could not forward cases as an agreement has been made at this port that goods cannot be transferred or delivered without the original B/L.

MESSRS OBLIGADO & CO. We have credited you in A.C. today with \$ 29.74 being the equivalent of £ 3.17.9. which these gentlemen inform us is in accordance with your instructions dated 22.12.31

These can be supplied at \$ 3.50 u.g. per 100 kilos placed POTATOES. alongside vessel for shipment end of June.

LIGHTERAGE. This can be calculated as \$ 57. on the Buenos Aires stores

and \$ 1.50 for the 3 cases of glassware ex "DESEADO".

SWEDES. We obtained some samples of these but find there is no demand here and although they are not grown in the Country they are charged the ridiculous import duty of 5 cents a kilo, which makes business out of the question. We have accordingly decided to leave them on board as there is no prospect of covering the duty.

"TEMBURY". This vessel only arrived here on the 11th inst so we had no option but to lighter the cargo brought by "LAFONIA". In view of the delay and extra expense of lighterage we approach Messrs Houlder Bros & Co for a reduction of freight but onlysucceeded in getting them to reduce 6d a ton. We enclose copies of Bills of Lading. As usual

we have asked the Captain of this vessel to report arrival by visual signal.

URDER FOR STORES. Your various orders have been duly executed.

SUGAR. We were quoted \$ 1.00 per 10 kilos or 10/6 per bag of 50 kilos and as there was a saving of 2/6 per 50 kilos by paying in sterling we have given the suppliers a draft on London for amount of their invoice.

TINS OF PEACHES. This account will also be paid by draft on London.

SHELL MEX.KEROSENE AND GAS OIL. The same remarks also applies to this invoice. The sterling rate for gas oil is 90/- and currency \$ 44. er plus \$ 6. for drums is equal to 130/2 at current rate of exchange while for the kerosene there is a saving of 1/- a case. We enclose a letter from this firm referring to these purchases and another quoting prices for oils in accordance with instructions received from their London office.

APPLES. A large consignment of apples has just arrived from New Zealand and as Mr Young informed us that when they could be bought by direct transhipment it would be in order to forward up to 25 cases we have decided after consulting with Captain Roberts to send 20 cases by this opportunity. These are in addition to the 14 cases from Argentina which are of the same mark and quality as last supplied. The price of \$ 8.50 for the New Zealand apples seems rather high but we may mention that in Argentina there is now a duty on imported apples of \$ 3.00 a case and the shipment just arrived will be probably sold there at \$ 22.00 Argentine paper a case while those landed in Montevideo are expected to fetch about \$ 17.00 Uruguayan gold.

CASTIGLIONI & LUCAS CALCRAFT. We enclose a letter from this firm referring

to same samples they are shipping per bearer.

FURTHER VOYAGES. We enclose herewith copy of letter received from Mr Cranston Woodhead dated 8th April in reply to ours about expenses. On receipt of your letter of 30th April we wrote again asking if he could make any proposition for the June/July voyage and have just received his reply copy of which we enclose. Please wire us if you wish him to go ahead with the business advising date steamer could present. We understand from Captain Hoberts that his cargo next voyagemarriving here about the 26th June, will be mostly wool, with some tallow for London and are endeavouring to secure space for seme but we shall be glad if you will kindly confirm this by wire before we definitely book.

Dear Sirs,

We beg to acknowledge receipt of your letters of 14th, 15th and 16th inst and confirm ours of the 1st inst as per attached press copy and also confirm wirelesses exchanged as per enclosed list. "LAFONIA". It was impossible to despatch this vessel on the 27th as you desired owing to the Easter holidays. These extended from the 20th to the 27th in Montevideo and from the 24th to the 27th in Buenos Aires, during which period the Custom House was closed. for the same reason the "POLZELLA" has been delayed and we have consequently had to incur lighterage on this cargo. The Agents now inform us she will not arrive before the 30th. We regret to say there is very little cargo from Montevideo to Magallanes and none offering for the present voyage. FURTHER VOYAGES. With regard to the Southern Brazil scheme Messrs Wilson Sons & Co have received a reply from their Rio Grande branch stating that they could not act as Agents for the "LAFONIA" owing to their connection with Mihanovich. We are informed that there is no likelihood of the latter chartering "LAFONIA" as they have four boats specially built for this trade and cannot find sufficient employement for them. These boats carry from 2.000 to 4.000 tons and can get to Porto Alegre. we enclose herewith copy of letter received yesterday from Mr Cranston Woodhead which is interesting. The amount calculated for expenses seems very high unless it includes all charges in Brazil and Buenos Aires or Montevideo, which is a point to be cleared up. The milreis is at present quoted at 4 13/64d so that the nett profit indicated of 14200\$000 for each voyage is equal to about £ 248.

calculates he should be able to do the round voyages excesive and calculates he should be able to do the round voyage in 11 days. From your wireless of the 24th advising that "LAFONIA" will leave yours on 1st May and from Montevideo on the 19th we gather that she will not be available for nio Grande in May/June as originally intended but we shall doubtless hear further about this. We understand from your letter of 15th March that "LAFONIA" will bring wool on the May and July voyages and seal oil in June if this business materialises. We await your reply to our message of the 26th to arrange for freight. As soon as we know when the Seal oil is coming forward we hope to be able to arrange with Lamport & Holt to ship same direct to Glasgow in which case the freight will be 27/6. If however the cargo has to

transhipped at Liverpool the transhipment expenses amount to 24/- in addition to the Liverpool rate of 25/"LAFONIA" DISBURSEMENTS.FEB/MARCH VOYAGE. We have to advise you that these expenses do not appear in your account as we have asked your London House to pay the equivalent to the Bank of London & South America itd. Copy of letter received from Mr C. Cranston Woodhead dated Rio Grande 21st March 1932.

Dear Mr Stapledon,

I have just returned from England, and hasten to reply to your

letter of 3rd inst, which I found here on my return.

I am of the opinion that there are good prospects for the new steamer "LAFCMIA", as during the rice season, which commences in April, large quantities are shipped from Porto Alegre and/or Rio Grande to the River Plate, principally Buenos Aires.

The Porto Alegre trade is almost exclusively in the hands of Mihanovich, with the Lloyd Brazileiro berthing odd ships whenever possible,

but from Rio Crande practically all ships load for the Plate.

Inward cargo is limited almost exclusively to wheat shipped from Bahia Bianca by Bunke and Born, and, as you say, these people probably have a contract with Mihanovich. We must therefore count on outward cargo only. I calculate that in, say 50 days the "LAFONIA" should be able to do two round trips Buenos Aires/Porto Alegre, inwards in ballast and outwards loaded with rice.

Mihanovich have about 3 sailings ver wonth and from Porto Alegre to Buenos Aires they charge \$ 5 Argentine gold per ton: The Lloyd Brazileiro when they have a sailing, charge 460,750, so that in order to enter this trade we should have to offer an inducement in the way of freight, say 40 or 450000 per ton. On this basis of 400000 the gross earnings per trip would be ebout 24:000\$000, and total expenses about 9:800\$000, say 14:200\$000 nett, equal to about 28 contos for two trips. Would this be satisfactory for Owners?.

On the other hand we might be fortunate enought to secure a full cargo or two from Rio Grande to Montevideo, the freight on which runs at about 55\$000 with free discharge. We would of course prefer this business, but if we are unsucessful would the Cwners consider the Porto Alegre/Buenos Aires run?.

Please let me know as soon as possible whether you would be interested in this business, and also when the ship could present, and I will then indicate exact prospects.

Dear Mr. Stapledon,

Many thanks for your letter of 6th.
inst., from which I note that the Falkland Islands Company
would like to fix up one voyage for "Lafonia" as an
experiment, and that she could be available for a voyage
between 27th. June - 12th. July.

In order to put a definite proposition before you, it will be necessary for the Falkland Islands Company to give us the opportunity of offering this steamer firm on the market, with the option of cancelling the call later in the case of insufficient inducement. Will you ask the Company to give this definite authority, when we will set to work and advise you what we can offer.

In this connection it will be necessary to know what weight she can lift, or cubic capacity, and on what maximum draft, and also when she could present, say in Porto Alegre, presuming she were to come up in ballast.

We will endevour to work the steamer on this market first, but failing sufficient inducement, we will work on Porto Alegre.

It may interest you to know that several parcels of salt in bags are being shipped from yours and Buenos Aires to Rio Grande, the shippers being Cia Uruguaya de Carbon y Sal and Ballester y Molina respectively: could you get into touch with these people with a view to possible inward

RIO GRANDE - BRAZEL.

RIO GRANDE, 8th. April 1932

Dear Mr. Stapledon,

Your letter of 30th ulto., to hand a few days ago, and I was glad to hear that my air-mail letter of 21st idem reached you in time for you to send a copy of same to the Falkland Islands Company by "Lafonia". Copies of telegrams exchanged on 26th are enclosed herewith.

I enclose a small statement showing how I arrive at the amount of estimated expenses which would be incurred by "Lafonia" (cut down to 9.200\$000), and from which you will note that expenses at discharging port are not included, although I understand that it is the custom at both yours and Buenos Aires for discharge to run for a/c of the goods.

My figures are necessarily only approximate, and it may be possible to improve on them in actual practice, but at all events you may rest assured that the question of expenses will have our careful attention.

My estimate of 2 round voyages in 30 days was arrived at as follows: 3 days steaming to Rio Grande (where in-bound foreign steamers receive pratique) 1 day Rio Grande/Forto Alegre, 3 days loading, 4 days Porto Alegre/Euenos Aires (direct) and 3 days discharging - 14 days, and even on this basis no allowance has been made for bad weather, rain, etc.

There are several shippers of herva matte in Porto Alegre and Rio Grande, Carlos Lubisco & Co. being undoubtedly the most important, but I believe that this firm has a contract with Mihanovich. Other shippers are in Rio Grande and generally utilise the regular Lines running south, and owing to competition, the rate of freight on this article has been cut down to about 60\$000 per ton weight.

There are also considerable quantities of timber moving from here and Porto Alegre to the River Plate, but owing to the nature of the cargo, slowness in loading and general necessity to discharge at the Boca (Buenos Aires), I do not consider this business worth considering, especially as the rate of freight is only about 40\$000 per ton weight.

Would Owners consider the carraige of wet hides loosely stowed from Rio Grande to Montevideo at 36\$000 per ton? During the season considerable quantities move from here for transhipment at yours to Europe.

I note that there is a possibility that "Lafonia" will now not be available for 3/4 weeks in May/June, but I shall be glad to have some definite information from you as soon as you hear from Stanley on the matter.

We are in receipt of your favour of 11th ult., from which we note that above vessel was delayed by bad weather on her return to Montevideo and only arrived at 6 p.m. on 4th July.-

We have now received all Port accounts for this vessel, and enclose our General Disbursement Account herewith, in duplicate, from which you will note that total expenses came to 10:386\$800, as against the estimated amount of 10:304\$300, so there is a small balance outstanding in our favour of 82\$500.

This difference is due to our having under estimated Bar pilotage (the ship crossed the Bar after dark), stamps, utilisation dues, State transit tax, crane hire, transport of the tobacco and mails, and slightly over estimated telegrams and overtime shifting berth.

It now remains to be seen whether the nett balance of 10:141\$400 covered expenses or left a profit on the voyage.— Our own idea is that the freight of 35\$000 is not sufficient to induce Owners to make another voyage.— Cargo for Montevideo is quite plentiful at the moment, the Swedish "San Francisco" having recently taken some 18.000 wet hides and barrels Casings to your port, and the T&H "Nasmyth" arrived to-day to receive 21,500 hides.— We understand that both these ships are charging freight on the basis of 36\$000, but even so this cannot be a paying proposition.— What is your idea of a remunerative freight for this business?

We shall be glad to know when "LAFONIA" could be available for another voyage to this port, and what freight the Owners would require, in the light of their previous experience.



We beg to acknowledge receipt of your letters of 14th, 15th end 16th inst and confirm ours of the 1st inst as per attached press copy and also confirm wirelesses exchanged as per enclosed list. "LAFONIA". It was impossible to despatch this vessel on the 27th as you desired owing to the Easter holidays. These extended from the 20th to the 27th in Montevideo and from the 24th to the 27th in Buenos Aires, during which period the Custom House was closed. For the same reason the "POLZELLA" has been delayed and we have consequently had to incur lighterage on this cargo. The Agents now inform us she will not arrive before the 30th. We regret to say there is very little cargo from Montevideo to Magallanes and none offering for the present voyage. FURTHER VOYAGES. With regard to the Southern Brazil scheme Messrs Wilson Sons & Co have received a reply from their Rio Grande branch stating that they could not act as Agents for the "LAFONIA" owing to their connection with Mihanovich. We are informed that there is no likelihood of the latter chartering "LAFONIA" as they have four boats specially built for this trade and cannot find sufficient employement for them. These boats carry from 2.000 to 4.000 tons and can get to Porto Alegre. We enclose herewith copy of letter received yesterday from Mr Cranston Woodhead which is interesting. The amount calculated for expenses seems very high unless it includes all charges in Brazil and Buenos Aires or Montevideo, which is a point to be cleared up. The milreis is at present quoted at 4 13/64d so that the nett profit indicated of 14200\$000 for each voyage is equal to about £ 248.
