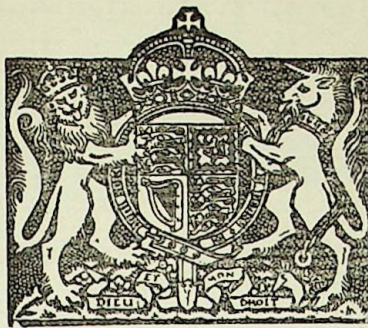

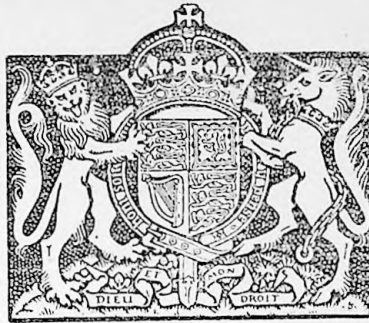

Dear Sir Miles.

I am afraid that your query regarding the issue of a Special Marriage Licence was not answered as promptly as I could have wished - the County Clerk wrote to me here, and this letter got here some days before I did.

I hope no great inconvenience was caused.

Speaking generally in cases in which an officiant says that some person "may" issue a licence, the person in question has a discretion to grant or refuse but should not refuse save on reasonable grounds. In the case of a marriage licence, since a special licence enables the marriage to take place at once without the interval of 3 weeks which is necessary in the case of banns or a

12
register's licence it would, I think, be right to ask why a special licence was being applied for, - if there was absolutely no reason given one might well refuse say that the parties could get an ordinary licence. As marriage by Special licence costs considerably more (£3 for the licence + £2 to the parson) I expect it will not be asked for, as a rule, unless there is some good reason.

I hope that I will be able to give you such assistance as you may from time to time require. If there is any drafting to be done it will be a help if I can be given as much of the background as possible - that is to say the local conditions & the particular reasons for any provisions that seem at all unusual. This might obviate the necessity for subsequent queries
