"Following from Sir Henry Webb begins your telegram 2nd June answer is no but should not refuse capriciously ends crown"

Sir Henry Webb was away from home at the time your telegram arrived, and, unfortunately, had no proofs of the Laws with him. He, therefore, asks us to convey his regrets to the Governor for the resulting delay. In writing to us he says that the Governor is not compelled to issue a Special Licence under Section 13 of Ordinance 16 of 1949 (the Marriage Ordinance), but at the same time he should not refuse to issue one from mere caprice. Putting it another way, he says, the applicant for a Special Licence to marry should be able to give some reason why he requires a Special rather than an Ordinary Licence.
