

McGARRELL FAMILY

NB: The following is prepared from Falkland Islands Registers and files – there may be other family born outside the Falklands. Unless stated otherwise, all dated births, deaths and marriages occurred in the Falklands and all numbered graves are in Stanley Cemetery. Various spellings of names are recorded as written at the time.

Daniel McGARRELL was born circa ?.

Daniel was married to **Mary Ann DUFFY**.

Daniel, Mary Ann and their son James arrived in the Falkland Islands sometime before April 1854.

On 21 October 1856 Daniel, a shopkeeper, purchased Crown Grants 92 and 93 for £33-9-7.

On 13 September 1858 James Lane, the Colonial Manager of the Falkland Islands Company Limited, reported to the London Office that Daniel, the salesman, was married with a family and appeared steady, zealous and competent in his work. [FIC/E3; 8]

On 9 December 1858 James Lane reported to the London Office that with regards to the Store, Daniel's time was fully occupied, often after hours. [FIC/E3; 24]

On 3 February 1859 James Lane reported to the London Office that the Company was well served and that Daniel was a particularly zealous servant. [FIC/E3; 32]

On 28 July 1859 James Lane reported to the London Office that he had taken out a licence in Daniel's name as agent for the Company and given him a gratuity of £2-2-0 as auctioneer. [FIC/E3; 84]

On 27 February 1862 Daniel signed a declaration that he had carefully and truly translated and read over in the Spanish language the declarations of José Maria Gonzales and Pedro Varela. [H18; 273]

On 3 December 1862 Daniel, a storekeeper, purchased Crown Grant 12 for £137.

On 23 February 1863 James Lane reported to the London Office that Daniel was desirous of bringing out his wife's sister's children, **Peter RILEY**, age 16, and **Ann RILEY**, age 11. Their parents were Joseph and Catherine RILEY and they lived at 45 Lower Stephen Street, Dublin. Daniel would pay their passage. [FIC/E1; 94]

On 23 May 1863 James Lane reported to the London Office that he had secured the 6,000 acres that the Bluff Creek House stood on by licence to Daniel.

Peter REILY, age 17 and a porter, and **Anne REILY**, age 12, were passengers on the *Matilda* leaving Humphrey's Dock, Hay's Wharf, Tooley Street, London on 12 July 1863. [H19]

On 9 September 1863 Daniel, a storekeeper, and Ann sold Crown Grant 93 containing 10 acres for £4.

On 15 March 1865 Daniel, a storekeeper, sold Crown Grant 12 for £140.

On 1 April 1865, Daniel, a storekeeper, sold Crown Grant 92 for £70.

FIRST GENERATION

Children of Daniel and Mary Ann McGARRELL:

1. **James MacGARREL** born circa 1850 (*not in the Falkland Islands*). James, age 5, was on the return of the Government School 1 April 1855. [H8]
2. **Mary Ann McGARRELL** born 9 April 1854 in Stanley. Her father's occupation was recorded as household servant.
3. **Daniel McGARRELL** born 23 February 1856 in Stanley. His father's occupation was recorded as labourer. Daniel, age 4 years and 5 months, accidentally drowned 28 July 1860 and was buried the same day in Grave D 311. The inscription on his headstone says '*I.H.S. Sacred to the memory of Daniel Joseph M.Garrell who departed this life June 25th 1860*'



4. **Thomas McGARRELL** born 4 June 1858 in Stanley. His father's occupation was recorded as labourer.
