DOCKYARD JETTY - DAMAGE DONE BY R.R.S "WILLIAM SCORESBY".

1 beg to report that the R.S. "William Scoresby", when coming alongside the Dockyard jetty on Monday the 9th November, 1931, hit the North East corner pile and broke the bollard just below deck level.

2. To make good this damage it is necessary to lift two deck planks, unbolt and loosen top stringers and one brace, strip Muntz metal sheeting from North East corner pile, scarf on new piece of 12" x 12" timber to pile, remetal, refasten stringers, brace and planking.

3. The estimated cost of this work is as follows:-
