Sir,

In accordance with the conditions of our lease as granted to us by the Government of the Falkland Islands, we must pay into the Colonial Treasury the sum of \$350.- annually before the first day of January.

On the present occasion we are afraid we will be hindered from making the said payment in due time owing to the lack of communications.

But, being desirous of complying strictly with the conditions referred to above, we beg Your Excellency to accept our cheque for \$350.- and to send it to the Falkland Island Government by the first opportunity.
