<u>287/152.</u> Further to my 282/152 of 13th November, Manager Pesca has submitted written application with plan to erect a building size ll metres by 6.5 metres. Construction concrete blocks. Use workshop for radar-asdic - gyro-radio workshop. Situation is on foreshore 85 metres S.S.E. approx of bridge over stream running out from under Hydro Electric Power Station. It is close to beached sailing ship hulk "Louise" that you will recall. Request information if this is within Pesca lease. Manager wishes begin building. If not within present main lease it would appear best that main lease be extended to cover everything up to and including W/T Station but excluding graveyard. Alternatively lease for new workshop on lines of present W/T Station lease appears appropriate and whole situation could be reviewed when main lease next expires. I have no information about that here.

2. If proposed workshop site is not with present lease have you objection to Manager beginning construction at Company's risk pending approval by His Excellency of written application. I realise this is irregular but site is between present main and W/T Station leases and I know no reason for eventual not granting.

I attach herewith an application received from the Manager, Compania Argentina De Pesca, Grytviken, for the lease of a very small plot of land almost adjacent to that Company's main lease at <sup>G</sup>rytviken. A sketch plan is attached. My telegrams <u>282/152</u> of 13th H November and <u>287/152</u> of the 19th November and your telegr-5 -am 313 of the 22nd November and letter number D/15/58 6 of 24th November, to which was attached a sketch plan 9 of the Company's existing lease, refer.

It appears that the application should have been made by the Company's Head Office in Buenos Aires to you. Doubtless you will wish to pursue the matter with that office. However, it is self-explanatory and I recommend it in principle. I have no details of the Pesca main lease here apart from the sketch that you sent. I should say that the most convenient thing to do would be to extend the main lease to include both the proposed site and the W/T station, but excluding the cemetary. ## MEMORANDUM NO. 2 FOR EXECUTIVE COUNCIL

### <u>lease of Land to the Compania Argentina de Pesca</u>

The area of land (500 acres) in South Georgia at present on lease (21 years from 1948) to the Compania Argentina de Pesca is shown on the attached sketch plan. In addition to the main area the Company have an annual lease of the land on which the small R.T. station stands (to the East of the Cemetery).


2. The company have now applied for a further lease of land on which to erect a Radic, Radar and Asdic Workshop. The area in question is approximately  $85\frac{1}{2}$ square yards and it is shown on the attached sketch plan as the small plot lying to the North East of the Cemetery and 90 yards to the South East of the present boundary in the vicinity of the Electric Power Station. In view of the urgency of the project and as there appeared to be no grounds for resisting the application the Company have been permitted to begin work on the workshop at their own risk.

3. The Company have intimated that it is their intention to apply for an extension to their main lease, when it comes up for renewal, so as to include the area in which the R.T. station and the Radio, Radar and Asdic Workshop are situated. There may be some objection to such a proposal in view of the desirability of not leasing the whole area round the cometery which in particular, contains the grave of Sir Ernest Shackleton. In the meantime, however, it is suggested for the consideration of Council that a ten year lease might be approved in the case of this small plot. It would then expire at the same time as the main lease expires.

WHEREAS the Sociedad Anonima Compania Argentina de Pesca, of the City of Buenos Aires, in the Argentine Republic, hereinafter called the Lessees, have made application for a lease of a parcel of land situate on the foreshore of King Edward Cove, East Cumberland Bay, in the Island of South Georgia, one of the Dependencies of the Colony of the Falkland Islands.

WE of our special Grace do by these Presents for Us, Gur Heirs and Successors, lease unto the said Lessees all that lot or parcel of land situate on the foreshore of King Edward Cove, Bast Cumberland Bay, in the Island of South Georgia, one of the Dependencies of the Colony of the Falkland Islands, containing 71.5 square metres (about 85.5 square yards), and more particularly described as to metes and bounds in the plan on the back hereof.


PROVIDED that this lease is granted subject to the reservations, conditions, and restrictions set forth in the Land Ordinance, save in so far as the same are expressly excluded in whole, or in part, and that the plot of land so leased is used by the Lessees for the purpose of creeting and maintaining a radarasdic- gyro- radio workshop and for no other purpose.

PROVIDED FURTHER that this lease is granted for a period of ten years, commencing on the 1st day of October, 1959, and ending on the 30th day of Septembor, 1969, both days inclusive, and that a rent of One Pound shall be paid by the Lessees yearly on the 1st day of October in every year during the continuance hereof.


