Sir,

I have written by this mail and asked my sister Mrs Lellman at Stanley to come to South Georgia for a change for a couple of months in the summer, should there of course be an opportunity direct from Stanley.

I would like during her stay that, she could live with me at the Quarters, and for this I beg the sanction of His Excellency the Governor. The new rooms will be completed in January, which will make a great difference to the comfort of the quarters. It will in no way interfere with the Officers quarters.

It is possible for me to arrange accommodation on the station but I would rather not place myself under any obligation to the whaling company, I therefore ask for His Excellency's sanction, and would be extremely obliged if it could be communicated to my sister in Stanley.


Madam,
